GENERAL INFORMATION AND GUIDELINES FOR THIS RFP

I. DESCRIPTION OF THE ORGANIZATION

The Navajo Nation Fire and Rescue Services is a emergency services program that responds to all incidents involving fire, EMS, hazmat and wildfires. NN Fire and Rescue Services operates eight fire stations across the Navajo Reservation in Arizona and New Mexico.

II. SCOPE OF THE CONTRACT

The Navajo Nation intends to enter into a professional services contract with one (1) responsive, qualified, and independent consultant/organization to complete all work as described in the attached scope of work.

III. RESPONDENT REQUIREMENTS

All respondents must have the capabilities listed herein, including sufficient detailed information with regard to experience and expertise in meeting the following requirements:

- 1. A legitimate and credible vendor with experience and history with providing the described services.
- 2. Vendor must be able to operate independently in providing described services for the program.
- 3. The Navajo Business Opportunity Act 5 NNC § 201, 205 will apply.
- 4. GSA pricing required.
- 5. As built drawings of all completed work.
- 6. All requested services requested to be completed by TBH.

The Navajo Nation reserves the right to reject any and all proposals, in whole or in part based on the requirements set forth in this RFP.

XIII. AGREEMENT TERMS AND CONDITIONS

The Navajo Nation is not bound to enter a contract under the RFP and may issue a subsequent RFP for the same services, and

The Navajo Nation is a sovereign government and all contracts entered into as a result for the RFP shall comply with the Navajo Nation law, rules and regulations, including the Navajo Preference in Employment Act, and applicable federal law, rules, and regulations. This procurement and any RFP with respondents that may result shall be governed by the laws of the Navajo Nation and applicable federal law. Nothing herein shall be constructed as a waiver of the Navajo Nation's sovereign immunity. In addition, the Navajo Nation Business Opportunity Act will apply to the RFP.

The Navajo Nation Professional Services Contract will provide all other legal and contractual obligations, terms, and requirements of this project.

SCOPE OF WORK

Navajo Nation Fire & Rescue Services – Bay Door installation at Tuba City Fire Station # 40, Chinle Fire Station # 50, and Shiprock Fire Station # 20.

Navajo Nation Fire and Rescue Services is looking to purchase, install two (4) commercial overhead doors. The Navajo Nation Fire and Rescue Services is an emergency services program that responds to all incidents involving Fire, EMS, hazmat and wildfires. The department operates eight fire stations across the Navajo Reservation in Arizona and New Mexico and responds to calls in remote areas throughout the Navajo Nation. The department is requesting:

Hardware and Installation:

- Purchase and install four (4) commercial overhead doors. Tuba City (2) commercial garage doors w/ remotes. Chinle (1) commercial garage door w/ remote. Shiprock (1) commercial garage door w/ remote.
- This includes the purchase, delivery, and installation of the doors. These doors will have remote capabilities and (2) extra remotes. Sensors for each door. Matching color and aesthetics of each fire station.
- Installation of all electrical wiring, hardware, and equipment that is necessary for the safe operation of the commercial garage door systems will be installed by vendor.
- All hardware and equipment must meet or exceed all durability requirements for constant usage of the fire station with ability to withstand rigid environments beyond normal wear and tear.
- All wiring, equipment, and hardware must be installed by vendor.
- Training on operations and maintenance of commercial overhead doors and equipment for firefighters after installation. Must provide hard copies of safe operation and maintenance of the overhead doors.
- All installation is preferred to be completed by February 2025.

NAVAJO NATION CERTIFICATION Regarding Debarment, Suspension, and Contracting Eligibility

- 1. Applicant entity acknowledges that to the best of its knowledge that the Applicant entity, either in its present form or in any identifiable capacity, has not, in accordance with 12 N.N.C. § 361:
 - A. Been convicted of the commission of criminal offenses incident to obtaining or attempting to obtain a public or private contract or subcontract, or in the performance of any such contract or subcontract;
 - B. Been convicted of embezzlement, theft, forgery, bribery, falsification or destruction of records, receiving stolen property, or other offenses indicating a lack of business integrity or honesty, which currently, seriously, and directly affect responsibility as a Navajo Nation contractor;
 - C. Been convicted under antitrust statutes arising out of the submission of bids or proposals;

- 2. Applicant acknowledges that if the Navajo Nation determines that the executed Certification provided herein is untrue or not wholly accurate, it shall be grounds for the Navajo Nation to terminate the contract and pursue other legal remedies, at the Navajo Nation's discretion.
- 3. Applicant certifies to the best of its knowledge that it is eligible to do business with the

Navajo Nation, in its present form or in any other identifiable capacity, pursuant to 12 N.N.C. § 1501 and 5 N.N.C. § 301. Applicant also acknowledges that per 12 N.N.C. § 1505, it will not be eligible to contract with the Navajo Nation if deemed ineligible by the appropriate department or entity of the Navajo Nation which receives the Applicant's request for consideration for a business opportunity.
