PURPOSE

- A. The Kayenta Chapter is soliciting proposals from a qualified and licensed HVAC contractor to furnish all labor, materials, and equipment for the installation of a complete Heating, Ventilation, and Air Conditioning (HVAC) system with the system being a Carrier or Trane Brand.

BACKGROUND

- A. The Kayenta Chapter is a governance-certified chapter operating under its Five Management System Policies and Procedures. The Kayenta Chapter currently consists of two full-time employees and serves community members registered to vote within its jurisdictional boundaries. The Kayenta Chapter seeks to improve the comfort, safety, and energy efficiency of its facility through the installation of a new HVAC system. The selected bidder will evaluate the building, recommend appropriately sized equipment, remove existing equipment (if applicable), and install a new HVAC system that meets current industry standards.

SCOPE OF WORK

- A. Project Details
- a. The bidder shall provide all labor, materials, equipment, transportation, and incidental items necessary to complete the project.
 - b. Services shall include, but are not limited to:
 - i. Conduct a site visit and verify existing conditions.
 - ii. Perform load calculations to determine proper equipment sizing
 - iii. Furnish all HVAC equipment (including ductwork)
 - iv. Install heating and cooling equipment
 - v. Install refrigerant lines

- vi. Install electrical disconnects and controls
- vii. Install programmable thermostats
- viii. Install condensate drain lines
- ix. Balance and test the HVAC system
- x. Start up and commission the system
- xi. Train Chapter staff personnel on operation and maintenance
- xii. Provide manufacturer's warranties and installation warranty
- xiii. Clean the work area upon completion

B. Pre-Work Assessment

- i. Perform a comprehensive inspection of any existing HVAC units.
- ii. Assess system performance, airflow, and operational efficiency
- iii. Troubleshoot electrical, mechanical, and control system components

C. Technical Requirements

- a. The HVAC system shall:
 - i. Meet applicable local, state, federal, and Navajo Nation requirements
 - ii. Be energy efficient
 - iii. Include programmable digital thermostat(s)
 - iv. Include all safety controls
 - v. Operate quietly and efficiently
 - vi. Be sized appropriately for the facility
 - vii. Include manufacturer's warranty

D. Bidder Qualifications

- a. Be licensed to perform HVAC work
- b. Have a minimum of five (5) years of HVAC installation experience
- c. Demonstrate experience installing commercial HVAC systems
- d. Have qualified and certified HVAC technicians

E. Deliverables

- a. The bidder shall provide:
 - i. Site assessment report
 - ii. HVAC equipment specifications
 - iii. Installation schedule
 - iv. Complete installation
 - v. Testing and balancing report
 - vi. Operations and Maintenance manual
 - vii. Warranty documentation
 - viii. Staff Training
 - ix. Final Inspection and acceptance

F. Quality Assurance

- a. Ensure that all work meets local building codes, manufacturer specifications, and industry best practices.
- b. All installed components shall operate smoothly and be fully functional at project completion

G. Conclusion

- a. Conduct a final walkthrough with the Chapter Manager and Chapter Officials and address any deficiencies before project closeout.

SUBMISSIONS

- A. All proposed bids shall be submitted in a sealed bid, in written documentation, and shall attach all required licenses and registrations to the Kayenta Chapter. All bids shall be submitted by mail or delivered in person to:

PRIORITY

- A. It is the responsibility of the Bidder to identify themselves as a certified vendor registered and in good standing with the Navajo Nation Business Opportunity Act. All Bidders are responsible for marking on the outside of their sealed bid, if applicable, their Priority Status Number (e.g, Priority One, Priority Two) as recorded by the Navajo Nation Business Opportunity Act.

REJECTIONS

- A. The Kayenta Chapter reserves the right to reject any or all statements of qualifications and shall be the sole judge of the merits of the respective statements of qualifications received.

PROCUREMENT ON REQUEST FOR PROPOSAL

- A. This RFP will be conducted in accordance with all applicable Navajo Nation Laws and Regulations, including the Navajo Nation Business Opportunity Act. All applicable rules, regulations, and law shall also be followed by all parties. Bidders should familiarize themselves with the Navajo Nation regulations and laws before submitting their proposed responses to this RFP. Bidders may request a copy of the Kayenta Chapter's Five Management System Procurement Policies from the Chapter Manager at any time up to the deadline.

AMENDMENTS TO SUBMITTED BIDS

- A. A Bidder who submitted their bid but needs to modify/ amend their bid may do so before the deadline for receipt of proposals. Such amended proposals must be a complete replacement for a previously submitted proposal and must be clearly identified in the transmittal letter.

PROPOSAL SUBMISSIONS

- A. All bids must be received on or before 5:00 pm (MDT) on September 04, 2026. Bidders who are mailing their bids should allow sufficient time for mail delivery to ensure timely receipt by the specified date. If a bid is mailed, it is recommended that the bid be sent by certified or registered mail to the address indicated on the cover sheet of the RFP. Late bids shall not be considered.

RESPONSE MATERIAL OWNERSHIP

- A. All materials submitted in response to this RFP shall become the property of the Kayenta Chapter and will not be returned to the Bidder. The Kayenta Chapter will retain responses received and may be reviewed by any person after the final selection has been. The Kayenta Chapter has the right to use any or all system ideas presented in reply to this RFP. Disqualification or non-selection of a Bidder or this proposal does not eliminate this right.

INCURRING COSTS

- A. Any cost(s) incurred by the Bidder in preparing, transmitting, presenting, or modifying the proposal or material of this RFP shall be the responsibility of the Bidder.

APPLICATION REQUIREMENTS

- A. Proposal Format
- B. Statement of Qualifications
- C. Resume and Three References

D. Cost and Budget Breakdown

- a. The Bidder must submit a cost and budget breakdown. The cost proposal must be submitted sealed separately. This section must include a detailed cost proposal broken down into the following areas:
 - i. Price of service fees
 - ii. Price of materials
 - iii. Navajo Nation Sales Tax of 6% and applicable local tax
 - iv. Total Cost

E. Other Additional Required Documents

- a. Contractor license
- b. Navajo Nation Debarment and Suspension Form
- c. Federal Internal Revenue Tax Form (W9)
- d. Licensed, bonded, and current General Liability Insurance as recommended and verified by the Navajo Nation Risk Management Program. The insurance shall name the Kayenta Chapter as an additional insured if subcontractors are performed under the RFP.
 - i. Copy of Certificate of Insurance with the Navajo Nation minimum insurance requirements:
 1. Commercial General Liability coverage, ISO CG 0001 Form or equivalent with minimum limits of \$1,000,000 per occurrence, \$2,000,000 aggregate;
 2. Auto Liability minimum limit of \$1,000,000 per accident and should include non-owned autos
 3. Workers' Compensation coverage with statutory benefits from Employers Liability coverage with a minimum of \$1,000,000/ \$1,000,000/ \$1,000,000.

SELECTION CRITERIA

- A. An evaluation team will evaluate the proposals received, in accordance with the general guidelines used herein. The Bidders should be prepared to provide any additional information the team deems necessary for the fair evaluation of proposals.
- B. Failure of a Bidder to provide any information requested in the RFP may result in disqualification of the proposal. All proposals must be endorsed with the signature of a responsible official having the authority to bind the Bidder to the execution of the contract.
- C. The sole objective of the review team will be to select the Bidder who is most responsible for the needs of the Kayenta Chapter. The specifications in the RFP represent the minimum performance necessary for a response. Based on the evaluation criteria established in this RFP, the review team will select and recommend the Bidder who best meets the objective. If there is only one responsive bid, Kayenta Chapter may elect to evaluate the RFP solely.

GENERAL TERMS AND CONDITIONS

- A. Standard Contract
 - a. Kayenta Chapter reserves the right to incorporate standard contract provision(s) into any contract negotiations because of a proposal submitted in response to the RFP.
- B. Taxes
 - a. Bidder shall comply with all applicable Navajo Nation tax laws under Title 24 of the Navajo Nation Code and corresponding regulations. All appropriate taxes should be included in cost, including the Navajo Nation Sales Tax. All work performed within the territorial jurisdiction of the Navajo Nation is subject to the Navajo Nation Sales Tax at 6% pursuant to 24 N.N.C § 601 et seq., and the Navajo Nation Sales Tax Regulations.
- C. Sovereignty
 - a. Nothing herein shall be considered a waiver, express or implied, of the sovereign immunity of the Navajo Nation, except to the limited extension provided for under the Navajo Nation Sovereign Immunity Act, as amended, at 1 N.N.C. §§ 551 et seq.
- D. Amendments
 - a. Any revisions, amendments, addenda, change orders, modifications, increase in payment over and above the original contract amount, or changes whatsoever to any provision of the RFP or scope of work shall be made only by a duly approved written agreement, deemed a modification, and signed by the Chapter Manager and Chapter President.
- E. Sufficient Appropriation

- a. A contract awarded as a result of this RFP is contingent upon the availability of funds. A contract may be terminated or reduced in scope if sufficient funds do not exist. Sending written notice to the Vendor shall affect such termination or reduction in scope. Kayenta Chapter's decision to terminate or reduce the scope due to the insufficient appropriations shall be accepted as final by the Bidder.

F. Warranties

- a. Bidder warrants that all labor, materials, equipment, and fixtures shall be of good quality, new, and that the Work will be free of defects in design, materials, and workmanship. Any portion of the Work not conforming to these requirements, including substitutions not properly approved and authorized by Kayenta Chapter, and including nonconformance relating to any materials, equipment, furnishings, labor, installation, or workmanship, may be considered defective. Additionally, Bidder will ensure all materials, equipment, and fixtures are covered by the warranty provided by the manufacturer and shall be at least twelve (12) months or more. At a minimum, the manufacturer's warranty shall cover installation errors, defective workmanship, and missing or incorrect parts for at least twelve (12) months or more.

G. Repair parts and service

- a. Bidder will repair, replace, or re-perform, or pay the Navajo Nation the reasonable cost of such repair, replacement, or re-performance, any portion of the work Kayenta Chapter deems in its discretion to be defective. Additionally, the manufacturer shall be able to furnish replacement parts or furnish service by providing a list of agencies where a stock of repair parts is available and can be secured in a reasonable time

H. Warrant Repair Work

- a. All work performance by the Bidder, to include parts and labor, shall be warranted for a period of at least one (1) year, commencing upon the date of the completion of the renovation.

I. Work Performed

- a. Work performed by the Bidder shall not void any manufacturer's warranty on equipment or fixtures. All warranty repairs must be initiated within forty-eight (48) hours after notification by the Chapter Manager

- Form 1099-K (merchant card and third-party network transactions).
- Form 1098 (home mortgage interest), 1098-E (student loan interest), and 1098-T (tuition).
- Form 1099-C (canceled debt).
- Form 1099-A (acquisition or abandonment of secured property).

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

Caution: If you don't return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See *What is backup withholding*, later.

By signing the filled-out form, you:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued);
2. Certify that you are not subject to backup withholding; or
3. Claim exemption from backup withholding if you are a U.S. exempt payee; and
4. Certify to your non-foreign status for purposes of withholding under chapter 3 or 4 of the Code (if applicable); and

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding. Payments made to foreign persons, including certain distributions, allocations of income, or transfers of sales proceeds, may be subject to withholding under chapter 3 or chapter 4 of the Code (sections 1441–1474). Under those rules, if a Form W-9 or other certification of non-foreign status has not been received, a withholding agent, transferee, or partnership (payor) generally applies presumption rules that may require the payor to withhold applicable tax from the recipient, owner, transferor, or partner (payee). See Pub. 515, *Withholding of Tax on Nonresident Aliens and Foreign Entities*.

The following persons must provide Form W-9 to the payor for purposes of establishing its non-foreign status.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the disregarded entity.
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the grantor trust.
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust and not the beneficiaries of the trust.

See Pub. 515 for more information on providing a Form W-9 or a certification of non-foreign status to avoid withholding.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person (under Regulations section 1.1441-1(b)(2)(iv) or other applicable section for chapter 3 or 4 purposes), do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515). If you are a qualified foreign pension fund under Regulations section 1.897(l)-1(d), or a partnership that is wholly owned by qualified foreign pension funds, that is treated as a non-foreign person for purposes of section 1445 withholding, do not use Form W-9. Instead, use Form W-8EXP (or other certification of non-foreign status).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a saving clause. Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
2. The treaty article addressing the income.
3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
4. The type and amount of income that qualifies for the exemption from tax.
5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if their stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first Protocol) and is relying on this exception to claim an exemption from tax on their scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called “backup withholding.” Payments that may be subject to backup withholding include, but are not limited to, interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third-party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester;
2. You do not certify your TIN when required (see the instructions for Part II for details);
3. The IRS tells the requester that you furnished an incorrect TIN;
4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only); or
5. You do not certify to the requester that you are not subject to backup withholding, as described in item 4 under “*By signing the filled-out form*” above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

See also *Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding*, earlier.

What Is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all U.S. account holders that are specified U.S. persons. Certain payees are exempt from FATCA reporting. See *Exemption from FATCA reporting code*, later, and the Instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you are no longer tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Line 1

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. • **Individual.** Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

Line 3b

Check this box if you are a partnership (including an LLC classified as a partnership for U.S. federal tax purposes), trust, or estate that has any foreign partners, owners, or beneficiaries, and you are providing this form to a partnership, trust, or estate, in which you have an ownership interest. You must check the box on line 3b if you receive a Form W-8 (or documentary evidence) from any partner, owner, or beneficiary establishing foreign status or if you receive a Form W-9 from any partner, owner, or beneficiary that has checked the box on line 3b.

Line 5

Part I. Taxpayer Identification Number (TIN)

For interest and dividend payments, and certain payments made with respect to readily tradable instruments, you will generally have 60 days to get a TIN and give it to the requester before you are subject to backup withholding on payments. The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Secure Your Tax Records From Identity Theft

Identity theft occurs when someone uses your personal information, such as your name, SSN, or other identifying information, without your permission to commit fraud or other crimes. An identity thief may use your SSN to get a job or may file a tax return using your SSN to receive a refund.

To reduce your risk:

- Protect your SSN,
- Ensure your employer is protecting your SSN, and
- Be careful when choosing a tax return preparer.

If your tax records are affected by identity theft and you receive a notice from the IRS, respond right away to the name and phone number printed on the IRS notice or letter.

Protect yourself from suspicious emails or phishing schemes.

Phishing is the creation and use of email and websites designed to mimic legitimate business emails and websites. The most common act is sending an email to a user falsely claiming to be an established legitimate enterprise in an attempt to scam the user into surrendering private information that will be used for identity theft.

The IRS does not initiate contacts with taxpayers via emails. Also, the IRS does not request personal detailed information through email or ask taxpayers for the PIN numbers, passwords, or similar secret access information for their credit card, bank, or other financial accounts.

If you receive an unsolicited email claiming to be from the IRS, forward this message to phishing@irs.gov. You may also report misuse of the IRS name, logo, or other IRS property to the Treasury Inspector General for Tax Administration (TIGTA) at 800-366-4484. You can forward suspicious emails to the Federal Trade Commission at spam@uce.gov or report them at www.ftc.gov/complaint. You can contact the FTC at www.ftc.gov/idtheft or 877-IDTHEFT (877-438-4338). If you have been the victim of identity theft, see www.IdentityTheft.gov and Pub. 5027.

Privacy Act Notice

Section 6109 of the Internal Revenue Code requires you to provide your correct TIN to persons (including federal agencies) who are required to file information returns with the IRS to report interest, dividends, or certain other income paid to you; mortgage interest you paid; the acquisition or abandonment of secured property; the cancellation of debt; or contributions you made to an IRA, Archer MSA, or HSA. 1. Applicant entity acknowledges that to the best of its knowledge that the Applicant entity, either in its present form or in any identifiable capacity, has not, in accordance with 12 N.N.C. § 361:
 - A. Been convicted of the commission of criminal offenses incident to obtaining or attempting to obtain a public or private contract or subcontract, or in the performance of any such contract or subcontract;
 - B. Been convicted of embezzlement, theft, forgery, bribery, falsification or destruction of records, receiving stolen property, or other offenses indicating a lack of business integrity or honesty, which currently, seriously, and directly affect responsibility as a Navajo Nation contractor;
 - C. Been convicted under antitrust statutes arising out of the submission of bids or proposals;
 - D. Violated contract provisions, including:
 - i. Deliberate failure, without good cause, to perform in accordance with the contract specifications or within the time limit provided in the contract,
 - ii. A recent record of failure to perform or of unsatisfactory performance with the terms of any contract, or
 - iii. Any other cause so serious and compelling as to affect responsibility as a Navajo Nation contractor, including debarment by another governmental entity.
2. Applicant acknowledges that if the Navajo Nation determines that the executed Certification provided herein is untrue or not wholly accurate, it shall be grounds for the Navajo Nation to terminate the contract and pursue other legal remedies, at the Navajo Nation's discretion.
3. Applicant certifies to the best of its knowledge that it is eligible to do business with the

Navajo Nation, in its present form or in any other identifiable capacity, pursuant to 12 N.N.C. § 1501 and 5 N.N.C. § 301. Applicant also acknowledges that per 12 N.N.C. § 1505, it will not be eligible to contract with the Navajo Nation if deemed ineligible by the appropriate department or entity of the Navajo Nation which receives the Applicant’s request for consideration for a business opportunity.
