This memo will serve as notification to all concerned that the following year end processing dates for the closing of the Fiscal Year

2025 activities for all General Funds programs which fund term ends on September 30, 2025. **The FMIS** System will be unavailable on September 30, 2025, therefore this will be the only notice provided by the Office of the Controller. Please prepare/plan as it is not guaranteed that your documents will be processed. The limiting factor depends on the workload. Do not wait to submit documents. This has been and is customary for the entire Navajo Nation for many years, please adhere accordingly.
